OFFICE ORDER

Sub: Withdrawal of M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) Ltd from the list of Non Performer- -Reg.

1. NHIDCL vide Office Order No. NHIDCL/CivilWork/DimapurBypass/ Nagaland/ 2019/SPL-1 dated 13.07.2022 had declared M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) Ltd as a Non Performer.

2. Pursuant to the request of M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) Ltd received vide letter dated 03.01.2023, to review the order for Non Performer on account of improved performance and the recommendation of the ED (P), the matter was considered by the Reviewing Authority. ED(T) and GM(T) informed that the performance of the AE has improved on all counts and they have satisfactorily addressed all the issues because of which they had been declared non-performer. Considering all issues, it has been decided to withdraw M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) from the list of Non Performer.

3. Accordingly, NHIDCL Order No. NHIDCL/CivilWork/DimapurBypass/ Nagaland/ 2019/SPL-1 dated 13.07.2022 declaring M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) Ltd as a Non Performer hereby stands withdrawn with immediate effect.

Ltd. in association with Sterling Indo Tech Consultants (P) Ltd has assured the Competent Authority that they will perform their duties on site promptly and efficiently and in case of any future infraction, NHIDCL shall be at liberty to take appropriate action against M/s Yongma Engineering Co. Ltd. in association with Sterling Indo Tech Consultants (P) Ltd.
