It is brought to notice of all the Division/Units of NHIDCL and other agencies of MoRTH that Sh. Mafiz Miah was appointed as "Quantity Surveyor" by M/s Almondz Global Infra-Consultant Limited in JV with Mangalam Associates for the work of Consultancy Service for Authority's Engineer for supervision of "Two lane with hard shoulders of Merangkong-Tamlu-Mon Road from: (i) Design Km 0.000 to Km 20.000 (Existing Km 0.000 to Km 20.456) (ii) Design Km 20.000 to Km 40.000 (Existing Km 20.456 to Km 41.065) (iii) Design Km 40.000 to Km 59.000 (Existing Km 41.065 to Km 60.345) (iv) Design Km 59.000 to km 86. 835 (Existing Km 60.345 to Km 98.065 in state of Nagaland under SARDP-NE on EPC mode.

- 2. As per **Section-6 of Term of Reference** Diploma holder candidate having relevant experience of about 12 years could be considered for the post of Quantity Surveyor. But, as per experience certificate enclosed in the CV, Mr. Mafiz Miah is a Diploma holder in Civil Engineering and as per enclosed experience certificate with relevant experience of 7 **years & 04 months only**, which does not qualify the minimum criteria set forth in the Contract Agreement, thereby violating the GCC clause 4.5 (d) of the Contract Agreement.
- 3. Clause 4.5 (d) of GCC reads that "In order to prevent the tendency of the personnel and consulting firm to submit incorrect and inflated CV, they should sign every page of CV before submission in order to authenticate that CV furnished by them is correct. The consulting firm and the personnel through consulting firm should be informed by Employer while accepting CV of the new personnel that if CV is found in correct and inflated at a later date, the personnel accepted would be removed from his assignment and debarred from further Employer's works for an appropriate period to be decided by Employer and the new proposed personnel in place of removed personnel would be paid 15% less salary than the original personnel. 15% reduction in the salary will be imposed as a penalty for submitting the incorrect information. This penalty will be imposed only once. If the same consulting firm submits incorrect information again second time, necessary action will be taken by Employer to black-list that firm."
- 4. Therefore, as per stipulation of the GCC clause 4.5(d) of the Contract Agreement, Sh. Mafiz Miah is hereby debarred for 1 year (12 month) from engagement on NHIDCL/MoRTH project of/or to be undertaken by it either directly or indirectly effective from the date of this order.
