PMC collects over ₹1k cr property tax Rebate For

Paying Dues Till July 31

Pune: Revenue collection of the civic body's property tax department has surpassed Rs1,000 crore for the 2023-24 financial year so far. PMC hopes to rake in another Rs 100 crore by month-end.

According to data from the Pune Municipal Corporation (PMC), the revenue collection from property tax was Rs1,073 crore between April 1 and July 27 this year.

"The civic administration has given more time this year to pay tax at discounted rates. Property ow-

ners, who pay their dues till July 31, will be eligible for the discount," said Ajit Deshmukh, the head of PMC's property tax department.

Civicofficials said property tax submission would be allowed even on government holidays and Sundays.

til July 27 and is hoping to rake in Rs100 crore in the next couple of days.

The civic body has also announced a lottery for diligent tax payers and will distribute prizes worth Rsl crore to them. All property tax payers, who will pay tax before July 31 will be eligible for the lottery.

This year, the revenue of the civic body is down by around Rs53 crore as the distribution of the bills was delayed. The civic administration was forced to reprint bills as the state government approved the reintroduction of 40% tax rebate for self-occupied properties

The distribution of bills starts around April 1 every vear. But this year, it started on May 15.

PMC officials said they had taken a few steps to reduce the number of defaulters and increase the revenue. According to officials, the civic body has planned to use data analytics, AI (artificial intelligence) and machine learning tools for satellite imaging for property tax assessment for old areas as well as newly merged areas.

The Pune civic body char-

ges property tax, which includes general tax, conservancy tax, sewage tax and street tax under Section 128A (1) of the Maharashtra Municipal Act. 1949. PMC has set a target of Rs2,318.15 crore for property tax collection in 2023-24.

The civic administration also expects to get nearly Rs300 crore from the water tax collected from residential properties as a component of property tax, taking the total expected revenue from property tax to Rs2.618.15 crore.

Earlier, the PMC officials had started using its new WhatsApp Chatbot feature to send out property tax bills to residents in the Pune civic limits. The civic body officials had claimed that errors regarding recipient addresses would be mitigated by sending bills on WhatsApp, said a resident.

The techie invested Rs 1,000 and earned Rs 1,650. "He was then told to invest more to earn more. The techie invested Rs 4.24 lakh and was duped," the officer added.

In Kothrud, a 22-year-old electrician from Paud Road lost Rs 3 lakh. Senior inspector Hemant Patil of the Kothrud police station said the complainant was offered a part-time job to like internet ads in May and was given Rs 50 per like. He first earned Rs 200 in this way. "Between June 16 and June 20, the victim transferred Rs 3 lakh and was duped," Patil added
