The North Eastern Electric Power Corporation Limited (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India invites Single-Stage Bid through online bidding System basis for the following work of AGBP as detailed below.

1.0 QUALIFYING REQUIREMENTS OF BIDDERS:

1.1 The bidders shall have the following Qualifying Criteria:

The bidders have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as disqualified bid.

(i).Experience of having successfully completed similar nature of works under State Govt./ Central Govt./PSU during last 7 (Seven) years (ending on last day of the month previous to the one in which applications are invited) should be either of the following. The bid not accompanied with earlier work order copy of similar nature along with completion certificate will be rejected.

- One completed work costing not less than the amount equals to 80% of the Tendered value OR
- Two completed works each costing not less than the amount equal to 50% of the Tendered value OR
- Three completed works each costing not less than the amount equal to 40% of the Tendered value.

**2.0 GENERAL REQUIREMENTS:**

- (a) Registration for GST
- (b) PAN (Permanent Account Number) for Income Tax
- (c) Solvency Certificate from any Nationalized Bank
- (d) Trade License

**3.0 BID FEE (Off-Line):** Bidders shall have to deposit BID FEE (Non-refundable) for participation in this instant tender of Rs. 1,180.00 (Rupees One thousand one hundred & eighty) only including GST. (as applicable as per Govt. rule). The cost of tender document shall deposited through "SB COLLECT" in to Neeeco (AGBP) SBI Account (Non-refundable) drawn in favour of "NEEPCO Ltd., Bokuloni, Dibrugarh, Assam.

**4.0 EARNEST MONEY DEPOSIT (EMD) Off-Line:** Bidders shall have to deposit Earnest Money as mentioned above in the NIB. The Earnest Money shall be deposited through "SB COLLECT" in to Neeeco (AGBP) SBI Account drawn in favour of "NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.

**5.0 The procedure/steps for payment by SB-COLLECT of State Bank of India (for payment of BID FEE & EMD) in to NEEPCO (AGBP) SBI Account as follows:**

**6.0** Both the receipt of Bid Fee & EMD and hard copies of qualifying documents & General requirements shall have to be submitted either personally or by Registered Post in a sealed envelope to "The Office of DGM(C), CWC, AGBP, NEEPCO Ltd., P.O. Bokuloni Chariali, Dist. Dibrugarh, Assam, Pin:- 786191" before 5 (five) days from the date of bid opening.

**7.0 BIDDING PROCEDURE:**

The Bidder shall submit the Bid under the Single-Stage bidding system in electronic form as follows:

**Envelope No. 1:** Shall contain receipt of scanned copy Bid Fee & Earnest Money Deposit (EMD) and documents in support of Qualifying Requirements.

**Envelope No. 2:** Shall contain Price Bid. Price Bids shall be considered only those Bidders who fulfills the qualifying requirements.

**8.0 E-Tendering / E-Procurement**

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded from <https://etenders.gov.in> and bids are to be submitted/uploaded through above e-tendering system. Guidelines for e-tendering system are available on e-tender portal.

**9.0 Registration for Participation in Bids:**

9.1 Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://etenders.gov.in/eprocure/app>) by clicking on the link “Online bidder Enrollment” on the CPP Portal which is free of charge.

9.2 As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.

9.3 Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.

9.4 Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.

9.5 Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

9.6 Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC/e-Token

All the bidders are requested to get themselves registered well in advance and no extra time will be considered for submission of bids for the delay in on-line Bidder Registration, if any.

- 10.3 Submission of bids shall not automatically construe qualification for evaluation.
- 10.4 Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 10.5 The bidder shall refer to the Instruction for online bid submission given as Annexure in Section-II of the bid document.


