Sealed Quotations with 120(One Hundred Twenty) days validity are invited from interested purchaser of *Old unserviceable Wooden Door* as detailed in Annexure-A for selling in numbers on " *AS IS WHERE IS BASIS* " and " *NO COMPLAINT BASIS* " subject to following terms and conditions :


**Terms & Conditions:**

01. Quotation shall be submitted under sealed cover indicating NIQ cum Auction Sale No., last date and time of submission, date and time of opening on the cover along with proper address of the authority inviting the tender.
02. Bidders can inspect the *Old unserviceable Wooden Door* physically which are kept in the *Civil Office of the Colony Complex of AGTCCPP*. In this matter, Sr. Manager(C), AGTCCPP may be contacted on any working day from 11 AM to 1 A.M. (except Govt. Holidays) from 17.07.17 to 16.08.17.
03. **Earnest money : Rs.300.00 ( Rupees Three Hundred )** only shall be deposited as earnest money in the form of Demand Draft/Call Deposit from any Nationalized Bank in favour of ' NEEPCO Ltd. ' and payable at ' Agartala ', failing which their quotation shall not be considered. If a bidder withdraws the tender while it is under consideration or after placement of order, his bid security/EMD shall be forfeited along with other action, as the Corporation deems fit. The EMD shall be made payable without any condition to Purchaser .The EMD of all unsuccessful bidders shall be returned only after placement of order with the successful bidder.
04. The successful bidder shall have to deposit the full bid amount in the form of Demand Draft/Call Deposit from any Nationalized Bank in favour of ' NEEPCO Ltd. ' and payable at ' Agartala ', within seven days from the receipt of Disposal Letter and lift the materials within seven days from the date of deposit of amount.
05. Bidders shall quote rates both in figures and words without any overwriting/ corrections in their quotation. If any difference will be found between the rates mentioned in figures and words then the higher of the two shall be considered. Rates should be at least same/ above of the Reserved price.
06. The disposal of the material shall normally be awarded to the highest bidder fulfilling all the terms/conditions as aforesaid or may be decided by the Department during the course of the commencement and completion of the disposal process.
07. Bidders/ Tenderers will not be allowed to admit any other person or assign, or sublet in any manner, the interest in the contract, after getting the offer.
08. The lot or lots shall be removed in full from the site with whatever faults and flaws in description or otherwise and no selection or sorting of the material will be allowed. Quantities, quality and sizes wherever stated are approximate and quantity may vary.
09. NEEPCO does not give warrantee or guarantee of the quantity, quality, sizes and chemical composition of each individual item in the lot or about the "End Use" or fitness for particular purpose. Goods are sold on the assumption that the bidder has inspected the lots prior to bidding and know what he is bidding for. No complaint shall be entertained after the lot is allotted to him.
10. **TAXES** : All bids invited are for the net amount accruable to NEEPCO and all taxes or other levies as applicable on the date of delivery. These taxes are required to be paid before taking delivery by the bidder/ tenderer.
11. Auction sale shall be treated as local sale only. Bidders should make their own arrangements under relevant Tax Laws to take the goods to their state( In case of outstation bidder ).

12. **INCIDENTAL/OTHER COSTS** : The cost of material handling i.e. loading charges along with taxes where-ever applicable, shall be borne by the bidder and payment has to be made to the NEEPCO at the rate prevailing at the time of taking delivery.
13. Deviations in any terms and conditions mentioned at any stage are not acceptable.
14. Un-signed bids would not be considered.
15. Successful Bidders are allowed to lift the materials only on working days (Monday to Friday) between 10.00 AM to 5.00 PM. No picking, choosing or sorting will be allowed in the premises.
16. In case, successful bidder does not lift the materials from NEEPCO's premises in complete manner within stipulated period after depositing the amount, then the bidder are liable to pay Rs.250.00 per day up to 15 days towards Ground Rent and after 15 days, the amount deposited will be forfeited without giving any notice. Successful Bidder is liable to remove all the materials from NEEPCO at their own cost. If any, theft/ fire/ damage or any type of mishappening occurs while removing the materials from NEEPCO premises, the same will be borne by the bidder. NEEPCO is not responsible for loss, damage or deterioration of the materials due to any cause whatsoever thereafter.
17. **Last Date and Place for submission of Bid** : The bidder shall submit their Quotation and EMD in a Sealed Envelope. These shall be received till 13:00 hrs. of 16-08-2017 at O/o the Sr. Manager (E/M) C&P, AGTCCPP, NEEPCO and shall be opened at 15:00 hrs. of the same day i.e. on 16-08-2017. In case 16-08-2017 is a holiday, the Quotation shall be opened on the next working day at 16:00 hrs. Quotations send by FAX shall not be considered.
18. The Bidder requested to note that participation in the bid shall be taken as acceptance of the terms & conditions as stated above. In case any condition(s) is/are not acceptable to the bidder, the same should be mentioned in the offer/quotation in clear terms.

The Corporation reserves the right to change/modify the requirements or to postpone/accept or reject the tender in full or part of this Notice or cancel without assigning any reason thereof and is not bound to accept the highest offer.
