The undersigned, on behalf of the Corporation hereby invites online bids under Single stage Two Envelope system through Domestic Competitive Bidding (DCB) route with a validity of 180 (One Hundred Eighty Days) from Manufacturers / Authorized dealers/ Reputed Agencies of Fire Fighting System for “**Supply , Overhauling, Rectification & Modification Work of Deluge Valve, Automation of Water Reservoir, Up gradation of Fire Hydrant Network & Equipments of Dikrong Power House, Ranganadi H.E. Plant, Dist Lower Subansiri, Arunachal Pradesh**”, as detailed herein under::

1. SCOPE:

The scope of work shall be the “Supply, Overhauling, Rectification & Modification Work of Deluge Valve, Automation of Water Reservoir, Up-gradation of Fire Hydrant Network & Equipments of Dikrong Power House, Ranganadi H.E. Plant, Dist Lower Subansiri, Arunachal Pradesh”. The terms and conditions governing this tender are detailed in the subsequent sections of the Bid Document.

2. COMPLETION TIME:

The Completion Period for entire work including Supply of Materials, Erection, Rectification, Modification, Up Gradation, Automation of Fire Fighting System shall be 60 (sixty) Days from the date of issue of detail order.

3. QUALIFYING REQUIREMENT:

- a) **TECHNICAL:** The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.
- (i) Trade License of the firm in case of reputed firms showing his credential as a firm dealing with Fire Fighting System.
- (ii) Certificate of incorporation in case of a company, partnership deed in case of a partnership firm as the credential of the firm.
- (iii) The bidders shall attach the following in support of his credentials:
- (i) In case of authorized Dealer - Valid Dealership certificate of the OEM of Fire Fighting System.
- (ii) In case of Manufacturers – License showing the firm to be manufacturer of the fire fighting System/Equipments.
- (iv) The bidder shall have executed/supplied Fire Fighting Equipments/ System to any Govt. /PSUs organizations/reputed firm in the order as specified below:
- (a) A single order of not less than ₹. 100.65 lacs executed by the firm in the last 03(three) years and the bidder shall submit the copy of the said supply order along with completion certificate duly endorsed by the executing authority

or

(b) Two orders of not less than ₹. 75.50 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders along with completion certificate duly endorsed by the executing authority

or

(c) Three orders of not less than ₹. 50.00 lacs each executed by the firm in the last 03(three) years and the bidder shall submit the copies of the largest supply orders along with completion certificate duly endorsed by the executing authority.

- (v) Details like valid PF code, PAN number, Bank account No (along with IFSC code) & GST Registration No & License under Contract Labour Regulation & Abolition Act 1970 should be submitted along with the Bid document.
- (vi) The bidder should possess valid EPF registration under EPF&MP Act, 1952 with code number and a copy of the same should be enclosed along with the Bid document

The documents submitted in support of the credential should be valid till the opening of the Bid as specified in the Tender.

b) FINANCIAL:

The bidders shall fulfill the requirements as stipulated below and furnish the relevant documents in support of the requirement along with the bid document submitted.

- (i) Annual turnover by the firm in the best three financial years out of last five financial year ending March 2020 should not be less than ₹. 250.00 Lacs.
- (ii) Solvency certificate, not older than 6 months, by the firm from a nationalized / scheduled bank specifying the firm is financially sound to execute the contract amounting to ₹. 192.00 Lacs.
- c) Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 3.0 above shall be submitted online along with the Techno-Commercial bid under Envelope – I, Bids submitted without fulfilling the qualifying requirements shall be rejected.
- d) The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to perform the work satisfactorily.
- e) Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to supply the item, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- f) Each bidder shall submit only 1 (one) bid. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
- g) If an agent submits bid on behalf of one manufacturer/ dealer, the same agent shall not submit a bid on behalf of another manufacturer/dealer in the same tender

4. SITE VISIT BY BIDDERS: All the interested bidders are requested to visit the Plant Site to access/survey the existing Fire Fighting System and nature/quantum of work to be carried out and site condition before quoting their price.

5. E-TENDERING / E-PROCUREMENT:

This tender is being processed through e-tendering/e-procurement system. The bidding documents are to be downloaded, filled in bids are to be submitted/ uploaded through e-tendering system of NEEPCO Ltd. at <https://etenders.gov.in>.

6. PARTICIPATING IN THE BID:

6.1 Portal Registration:

The bidders intending to participate in the e-tendering and download the detailed bid document have to register themselves in the portal <https://etenders.gov.in>. Relevant information about the bidder required during the registration is available in the portal.

Vendor registration: Vendor Registration in the portal is free of charges. The details of registration procedure is available on the web site <https://etenders.gov.in/e procure/app> under category “Downloads” . The details are also given under Section-II’ Instruction to Bidders’ as Annexure-B (‘Instruction for online Bid Submission’).

7. PROCEDURE FOR PAYMENT OF BID FEES & EMD:

7.1 Bid Fees

- a) Bidder shall make payment of non-refundable Bid fees of amount ₹. 2,360.00 (Rupees **Two Thousand Three Hundred Sixty**) only inclusive of GST @18% online through “SB Collect” details of which is given in the Section-II **Instruction to Bidders at Sl. No. 8.1**. A copy of payment receipt to be uploaded in the e-tendering site falling which the bid shall not be considered. Further Documentary evidence of the Bid Fees paid shall accompany the Technical Bid. The invoice against the Bid Fee shall be submitted to the bidder after opening of the e-tender.
- c) Bids received online without Cost of Bid Documents unless exempted shall be rejected.
- d) Please ensure that payment of Bid Fee is made under “RHEP PARTIES” only in SB Collect.
- e) Payment of bid fee in any other mode will not be accepted.

7.2 EMD:

7.2.1 Through SB Collect

- a) Bidder shall make payment of refundable EMD of amount ₹. **2,50,000/- (Rupees Two Lacs Fifty Thousand)** only online through “SB Collect” details of which is given in the section **Instruction to Bidder at Sl. No. 8.1**. A copy of payment e-receipt to be uploaded in the e-tendering site falling which the bid shall not be considered.

7.2.2 Through Bank Guarantee

- a) Bidders can also make payment of EMD in the form of Bank Guarantee from a nationalised/scheduled bank for an amount of ₹. **2,50,000/- (Rupees Two Lacs Fifty Thousand)** only, details of which is given in the section **Instruction to Bidder at Sl. No. 8.2**

7.2.3 If submitted through Bank Guarantee, receipt of off-line documents should be before the specified date.

7.2.4 Bids received online without EMD unless exempted shall be rejected.

7.3 Exemptions for MSME’s shall be applicable under the Govt. of India norms under PPC guidelines.

13. Any action on the part of the bidder to revise the price or to change the structure of the price at his own instance after opening of the bid and within the validity of the offer shall not be possible.

14. NEEPCO reserves the right to extend the last date and time for submission of Bid.
