The North Eastern Electric Power Corporation (NEEPCO), a public Sector Enterprise under the Ministry of Power, Government of India invites Single -Stage Bid through ON-LINE bidding system from reputed and experienced bidders for the following work.

QUALIFYING REQUIREMENTS OF BIDDERS:

1.0: The bidder shall have the following Qualifying Criteria:

1.1 The bidders have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid shall be rejected and their bid shall be considered as disqualified bid.

Experience of having successfully completed similar nature of works under State Govt./ Central Govt./PSU works (work order copy & completion certificate to be enclosed with the tender document) during last 7 (Seven) years (ending on the last day of the month previous to the one in which the tenders are invited) should be either of the following:

- One completed work costing not less than the amount equals to 80% of the Tendered value
OR
- Two completed works each costing not less than the amount equal to 50% of the Tendered value
OR
- Three completed works each costing not less than the amount equal to 40% of the Tendered value.

1.2. The bidder shall furnish copies of the following documents:

- a) Solvency Certificate from any Nationalized Bank
- b) PAN (Permanent Account Number) for Income Tax
- c) Registration for GST
- d) Trade License

2.0: (i) Micro & Small Enterprises (MSEs): MSEs shall have to provide valid Exemption Certificate if any against payment of EMD.

(ii) Scheduled Cast (SC)/ Scheduled Tribe (ST) Entrepreneurs shall have to furnish certificate in support of their proof as SC/ST category while submitting the tender.

3.0: Each bidder shall submit only 1(one) bid. A bidder who submits or participates in more than 1 (one) bid against will be disqualified.

4.0 Bidders shall have to submit self-attested documents as mentioned above in On-line.

5.0 BID FEE: (Off-Line): Bidders shall have to deposit BID FEE (non-refundable) for participation in this instant tender of Rs.1180.00 (Rupees One Thousand one hundred eighty) only including GST (applicable as per GST rule). The cost of tender document shall be deposited through "SB COLLECT" in to Neepco (AGBP) SBI Account (Non- refundable) drawn in favour of "NEEPCO Ltd., Bokuloni. Dibrugarh, Assam.

6.0 EARNEST MONEY DEPOSIT (EMD) Off-LINE: Bidder shall have to deposit Earnest Money as mentioned above in the NIB .The Earnest Money shall be deposited through "SB COLLECT" in to Neepco (AGBP) SBI Account drawn in favour of "NEEPCO Ltd., Bokuloni, Dist. Dibrugarh, Assam.

STEPS OF SB COLLECT in to Neepco (AGBP) SBI Account.

- 1) Visit "On line SBI.com."
- 2) Go for "SB COLLECT" icon on top.
- 3) Read Accept the terms & condition and proceed.
- 4) Select "Assam " against State of Corporation.
- 5) Select "PSU " against type of Corporation & go to "**NORTH EASTERN ELECTRIC POWER CORPORATION LTD " then submit.**
- 6) Select ' AGBP parties ' as the case may be & submit.
- 7) Feed Necessary information in the appropriate boxes.
- 8) Payment through ' Internet Banking ' SBI Branch , SBI Buddy or Card Payment etc.
- 9) Print Copies of receipt and submit.

Any bid not accompanied by BID Fee & EMD will be rejected.

7.0 Both the receipt of Bid Fee & EMD and hard copies of qualifying documents shall have to be submitted in sealed envelope separately to "The office of DGM (C), CWC, AGBP, NEEPCO Ltd. P.O: Bokuloni Chariali, Dist: Dibrugarh, Assam, PIN: 786191"on or before the date mentioned at Clause No .(9) of NIB.

8.0 Failing to comply above or without submission of any one of the above mentioned documents or criteria, the bid shall not be considered for any evaluation and summarily rejected.

9.1: Bidders shall submit their bids in the electronic form in Online bidding forms will be available in the below website.



14. BIDDING PROCEDURE:

- (a) The bidder shall submit their bid under single Stage Bid System in the electronic form through e-Tender in two separate envelopes as follows :-
- (1) Envelope No.1: Shall contain Bid Fee and Earnest Money Deposit (EMD) and documents in support of Qualifying requirements.
 - (2) Envelope No. 2: Shall contain Price Bid.
- (b) Price Bid shall be considered only for those bidders who fulfill the Qualifying requirements as per clauses of NIB.

15. Bidders are requested to visit <https://www.neepco.co.in> and <https://etenders.gov.in> regularly for any *corrigendum/amendments/modification/clarification of the bid document*.
16. NEEPCO may allow preferences to Govt. / PSU / SSI / NSIC/ MSMEs units as per Govt. Policy and Guidelines. However, necessary valid authenticated documents as a proof has to be submitted in on-line mode by the bidders.
17. Submission of bids shall not automatically construe qualification of bid document.
18. The bidders shall not be entitled during the validity period of their offer without the consent in writing of the Corporation to revoke or withdraw their tenders or vary the tender /term thereof in any respect, failing which the Corporation shall forfeit his Earnest Money deposited along with the tender.
19. NEEPCO reserves the right to extend the last date and time for submission of Bid.
20. The Corporation reserves the right to accept or reject any or all tenders in part or full without assigning any reasons thereof and is not bound to accept the lowest tender.
