The North Eastern Electric Power Corporation (NEEPCO), a public Sector Enterprise under the Ministry of Power, Government of India invites Single -Stage Bid through ON-LINE bidding from reputed and experienced bidders for the following work.

QUALIFYING REQUIREMENTS:

- 1) Prospective bidders have to submit the following particulars along with their bid. Without the following documents, the bid shall not be considered to any intending firm(s)/ contractors and bid will be rejected and their bid will be considered as disqualified bid.
- 1) Experience of having successfully completed similar nature of works under State Govt./ Central Govt./PSU works ( work order copy to be enclosed with the tender document) during last 7 (Seven) years ending last day of the month previous to the one in which applications are invited should be either of the following:
  - a) One completed work costing not less than the amount equals to 80% of the Tendered value OR
  - b) Two completed works each costing not less than the amount equal to 50% of the Tendered value OR
  - c) Three completed works each costing not less than the amount equal to 40% of the Tendered value.

**(II)**

- a) Solvency Certificate from any Nationalized Bank
- b) Pan Number.
- c) GST Registration No.
- d) Trade License.
- e) Certificate to be enclosed as a proof of SC/ST
- f) MSEs (Micro & Small Enterprises) to provide valid Exemption Certificate if any against payment of EMD.

2). Bidders shall have to submit self-attested documents alongwith application of Bid submission as mentioned above in On-line.

3). SUBMISSION OF BID: The bid shall be submitted online only.

4). BID FEE: (Off-LINE): Bidders shall have to submit a BID FEE (non-refundable) for participation in this instant tender of Rs.1000.00 (Rupees One Thousand) only .The cost of tender document shall be deposited through “SB COLLECT” in to Neeeco (AGBP ) SBI Account (Non– refundable) drawn in favour of “NEEPCO Ltd., BOKULONI .Dibrugarh, Assam.

5). EARNEST MONEY DEPOSIT (EMD) Off-LINE: Bidder shall have to submit Earnest Money as mentioned above in the NIB No. AGBP/CWC/35 Dated. 07.11.2017. The Earnest Money shall be deposited through “SB COLLECT” in to Neeeco (AGBP ) SBI Account drawn in favour of “NEEPCO Ltd., BOKULONI .Dibrugarh, Assam.

Bid without BID FEE & EMD in the manner specified above shall be summarily rejected.

Both the receipt of Bid Fee and EMD along with qualifying documents shall have to be submitted to ON LINE in envelope separately.

The EMD of unsuccessful bidders shall be returned after finalization of the bid. However, EMD of successful bidder shall be returned after submission of Security deposit (SD).

6). Failing to comply above or without submission of any one of the above mentioned documents or criteria, the bid shall not be considered for any evaluation and summarily rejected.

7). SUBMISSION and OPENING of BIDS:

7.1: Bidders shall submit their bids in the electronic form in <https://neepco.abcprocure.com>. Online bidding forms will be available in the above website.

## 8. Participation in Bids:

### i. Portal Registration for e-tendering:

The bidders intending to participate in the e-tendering and to download the detailed bid document have to register themselves in the NEEPCO's e-tendering portal <https://neepco.abcprocure.com>. The registration shall be valid for one year from the date of registration. The Bidders who have already registered in NEEPCO's e-tendering portal having valid registration need not to register again. However, such bidders are to ensure that their registration in the e-tendering system is valid till the completion of the entire bidding process of the relevant NIB. Relevant information about the bidder required for registration is available in the portal.

### ii. Bidder Registration Fee:


The fee for Bidder Registration in the portal is Rs.3, 000.00 (Rupees Three thousand) only per year (Non-refundable). Payment of Vendor's fee for registration in on line either by net banking or NEFT/RTGS. Except these no other forms of registration is allowed.

### iv. BIDDING PROCEDURE:

- (a) The bidder shall submit their bid under single Stage Bid System in the electronic form through e –Tender in three separate sealed envelopes as follows :-
- (1) Upload scan copies of **receipt** Envelope for Bid Fee and EMD
  - (2) Envelope for Technical Bid to submit Qualifying Documents and
  - (3) Envelope for Price Bid.
- (b) Price Bid shall be opened only for those bidders who fulfill the qualifying requirements as mentioned at Clause No.1. above.
- (c) Bidders are requested to visit <https://neepco.abcprocur.com> regularly for any corrigendum/amendments/modification/clarification of the bid document.
- v. NEEPCO may allow preferences to Govt. / PSU / SSI / NSIC/ MSMEs units as per Govt. Policy and Guidelines. However, necessary valid authenticated documents as a proof has to be submitted in on-line mode by the bidders.
- vi. Submission of bids shall not automatically construe qualification of bid document.
- vii. The bidders shall not be entitled during the validity period of their offer without the consent in writing of the Corporation to revoke or withdraw their tenders or vary the tender /term thereof in any respect, failing which the Corporation shall forfeit his Earnest Money deposited along with the tender.
- viii. The Corporation reserves the right to accept or reject any or all tenders in part or full without assigning any reasons thereof and is not bound to accept the lowest tender.
