Plant , Sopo (110 MW), NEEPCO Ltd., Arunachal Pradesh.

1. Name of work : "Construction of Permanent A-Type quarter of one block having 4(four) units and1(one) septic tank at power house site, PHEP, Sopo, A.P. (Building no. A-03)".
2. Estimated Cost : Rs.56,51,794.00 (Rupees Fifty Six Lakh Fifty One Thousand Seven Hundred Ninety Four) Only.
3. Earnest Money : 2.5% of estimated cost for General Category & 1.0% of estimated cost for ST & SC Category
4. Time of Completion : 8 (Eight) months.
5. ## A. Qualification & Experience:

- i. Experience of having successfully completed similar nature of works during last 7(Seven) years should be either of the following:-
- ii. Three similar works costing not less than the amount equal to 40% of the estimated cost.  
Or
- iii. Two similar works costing not less than the amount equal to 50% of the estimated cost  
Or
- iv. One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- v. Bidder should have enlistment under P.W.D./C.P.W.D./M.E.S./PSU for an amount equivalent to the tendered amount/ estimated cost having experience in execution of similar nature of works.

(N.B.: Similar nature of works as mentioned means experience having execution of RCC Building works and other associated building works etc.)

- vi. Trading license of firm (upto date)
- vii. ST / SC certificate
- viii. An authenticated copy of the GST registration certificate with up to date payment

(a). 60% of amount put to bid.
- xv. Name and addresses of the sole proprietor/partners/board of directors and memorandum of articles of association/photocopy of the partnership deed/ affidavit for proprietorship.
- xvi. An affidavit that the information furnished with the bid documents is correct in all respects; and Failure to produce the certificates shall make the bid non – responsive



**B. Other Terms & Conditions:**

- a) *Tender documents* can be obtained from the office of the undersigned on **17/10/2019 to 22/10/2019 at 10:00 Hrs to 13:00 Hrs** with an application for issue of tender documents along with payment of the cost of the tender documents (Non-Refundable) in the form of Demand Draft/ Banker's Cheque only in favour of NEEPCO Ltd. Payable at Doimukh.
- b) The Contractor shall have to quote the rate sheet (Bill of Quantities and Schedule of rates) including all applicable taxes as mentioned in Cl. B (f). Use of correction fluid and over writing in bill of quantity (BOQ) shall not be allowed. Tempering of tender documents in any form shall be out rightly rejected.
- c) The Contractor shall have to supply all materials and labour etc. including completion of the work satisfactorily.
- d) Security Deposit: 10% security money will be deducted from the bill for due performance of the work and the same will be released after defect liability period. The defect liability period minimum 1(One) year or 365 days from the date of completion of work. If any defect is noticed during the above period the contractor will have to rectify the same at his cost and risk otherwise the Corporation will get the work done at the cost and risk of the contractor.
- e) EMD may be released after successful completion of the work and further, EMD of unsuccessful bidders will be released after finalization of tender.
- f) The Contractor shall have to quote the rate sheet (Bill of Quantities and Schedule of rates) inclusive of all taxes, GST, labour cess, TDS and duties. GST as applicable shall be paid by contractor himself. The department shall deduct from the bills, the TDS as applicable. The contractor shall quotes his or her rate considering all such taxes.
- g) Laws of Regulations and Acts related to Labour, environment protection, Safety etc. will be applicable.
- h) In case of delay in execution of the work 0.5% of the defaulted amount will be recovered from the bill per week of delay subject to 10% of the value of the work.
- i) Liquidated Damage: If the work has not carried out the work as per specification or not as per satisfaction of the Corporation or if the contractor caused any damage to the work or property of the Corporation or other damage not mentioned herein, the Corporation have the right to recover any amount as considered suitable from the bill/ Security deposit/ any other amount due to the contractor in Corporation.
- j) Bidders are requested to visit the site prior to participation of the Tender, Land acquisition, local problem and compensation if any, is at sole responsibility of the bidder. An affidavit in this respect by the bidder shall as a part of the Contract Agreement.

k) The decision of the Corporation for issuance of Tender Document shall be final and no correspondence in this respect shall be entertained. Mere issuance of tender document shall not however automatically qualify the bidder for the work.

l) The Technical bid will be opened first and evaluate to assess the technical and financial capability of the contractor/firm and their work experiences. Based on such evaluation and after adopting the post qualification procedure the price bid containing schedule of quantities shall be opened for further evaluation.


