Name of the work: "in situ servicing / testing/setting and popping of BHEL make Spring Loaded boiler safety valves of HRSGs and Aux steam Header".

Undersigned, on behalf of CGM & HOP, AGBP, NEEPCO Ltd. Invites ON LINE bids from prospective experienced bidders under the single stage two envelope bidding system through domestic competitive bidding with 180 (one hundred eighty) for "in situ repairing/servicing / testing/setting and popping of BHEL make Spring Loaded safety valves of HRSGs and aux steam headers. Technical specification of valves and detail scope of work as mentioned in Section-V".

1.0 Qualifying Requirement for Bidders:

- a) The bidder should have adequate experience of carrying out servicing of spring loaded safety valve of various sizes and rating and subsequent experience of in situ testing and popping of safety valve as per approved documents of manufacturer/end users.
- b) The bidder shall have to produce copy of experienced certificate/work order copy of similar nature of work covering the scope of work as mentioned above executed in any GOVT/PSU/reputed private sector organization having boiler/HRSG with working pressure not less than 41 kg/cm² and steam generating capacity not less than 65TPH.

NOTE: without fulfilling prequalification criteria as stated above, submitted bid shall be technically rejected. *Relaxation of Norms for Startups and Micro /Small Enterprises (MSEs) on Prior Experience and fulfillment of requisite Turnover criteria shall be applicable to some extent but shall not be waived considering criticality of the job to be executed.*
