North Eastern Electric Power Corporation Ltd., (NEEPCO), a Public Sector Enterprise under the Ministry of Power, Government of India, invites sealed bids with 120days validity from prospective experienced bidders under the Single-Stage Two-Envelope bidding system through Domestic Competitive Bidding (DCB) route for awarding the contract of **“Supply, Installation, Testing and Commissioning of inverter technology based VRF type air conditioning (Mitsubishi /Samsung /Daikin) with all necessary accessories piping’s etc. at 4 X 50 MW Kopili Power Station at KHEP, NEEPCO Ltd. , Umrongso , Dima Hasao, Assam.”**

**DETAILS OF THE NIT:**

**1.0 QUALIFYING REQUIREMENT OF BIDDERS :**

The bidder shall provide satisfactory evidence concerning the following:

**1.1 Technical:**

- i) The bidder should be a Manufacturer/Authorised Dealer of the equipment to be supplied and should have service center in North Eastern Region. Bid submitted by authorized dealer should be supported by their dealership certificate.
- ii) The intending bidder should have experience in execution of similar contract in any Government (either central or state) organization / PSU/IPP (**Independent Power Producer**) in India.

The above experience should be preferably with any Government department / PSU / IPP. Documentary evidence in support of experience and successful completion of works during last 7(seven) years ending March 2016 should be submitted by the bidder.

iii) **The intending bidder should have experience in execution of similar supplies to any Government department/ PSU/ IPP( Independent Power Producer) during last 7 years as follows:**

a) At least one similar supply order of having contract value not less than Rs. 36,00,000/- ( Thirty Six Lakh ).

OR

b) At least two similar supply orders having contract value not less than Rs.27,00,000/ ( Twenty Seven Lakh) each

OR

c) At least three similar supply orders having contract value not less than Rs. 18,00,000/- ( Thirty Lakh )each

Documentary evidence (supply order copies) in support of execution of similar work must be submitted along with the bid. **Non-submission of documents in support of similar experience may result in disqualification.**

However, the work order copies issued by any Private firm must be supported by TDS certificate issued against the respective work order/ contract.

- **Similar supply/ work shall mean:** Supply, Installation, Testing and Commissioning of inverter technology based VRF type air conditioning (Mitsubishi /Samsung /Daikin) with all necessary accessories piping's etc.

iv) Bidder should also submit along with their bid the documentary evidence / performance certificate from their end users ( preferable Govt. / PSU / IPP firms) in support of satisfactory operation of **their similar installation** during last 7 (seven) years.

v) Details like year-wise value of similar supply orders executed and documentary evidence of work completion along with order copies shall be furnished.

vi) Authorized dealer may produce credentials of their Principal also to fulfil the qualifying requirements.

## 1.2 **Financial:**

### (a) **Minimum Average Annual Turn Over (MAAT):**

The average annual turnover of the bidder in the best 3 (three) financial years should not be less than Rs. 90,00,000/- (Ninety Lakh ). Other income will not be considered for arriving at annual turnover.

(b) Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account and other financial statements for the preceding 3(three) financial years, ending 31<sup>st</sup> March 2016. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be acceptable.

(c) Letter of adequacy/ solvency and commitment from their Bankers/Financial Institutions should be furnished along with their bids .

**Authenticated documentary evidence in support of qualifying requirements, as mentioned under Serial No. 1.0 above shall be submitted alongwith the containing Techno-Commercial bid alongwith Bid Guarantee. For qualifying requirements specified at Para 1.1 & 1.2 above, the documents should be in the form of**

**Certificate of Clients/Owners. Bids submitted without fulfilling the qualifying requirements shall be rejected.**

- (d) Authorized dealer may also produce credentials of their Principal to fulfil the technical and financial qualifying requirements.
- 1.3 The bidder shall furnish copies of the following Registration Certificates:
- (a) Registration for Service Tax
  - (b) Registration for Sales Tax ( CST & VAT )
  - (c) PAN (Permanent Account Number) for Income Tax

- 1.4 The bidders shall also provide satisfactory evidence with respect to the following:
- a. They do not anticipate change in the Ownership of their concern during the proposed period of work. If such a change is anticipated, the scope and effect thereof shall be defined.
  - b. They have adequate financial stability and status to meet the financial obligations pursuant to the scope of the works and latest Banker's certificate indicating amount in support of solvency may be enclosed.
  - c. The bidder shall submit copies of their audited Annual Reports and Balance Sheet for the last 3 (three) years and the latest Sales Tax Clearance Certificate/ Sales Tax Return.

In case bidders are unable to furnish such certificates, they shall give valid reason for the same. The Owner reserves the right to reject any bid for the reasons of the bidder's inability to furnish such certificate is not mentioned in the bids.

- 1.5 In addition, bidders shall satisfactorily establish that they fully meet the qualifying requirements specified in the accompanying Technical Specifications. This is essential for consideration of bidders' proposal.
- 1.6 Bidders shall not be under declaration of ineligibility for corrupt and fraudulent practices issued by any Govt. dept./ PSU etc.
- 1.7 The above requirements are minimum and the Corporation reserves the right to request for any additional information and also reserves the right to reject the proposal of any bidder if, in the opinion of Owner, the qualification data furnished by the bidder is incomplete or the bidder is found to be not qualified to satisfactorily perform the works.
- 1.8 Notwithstanding anything stated above, the Corporation reserves the right to assess bidders' capability and capacity to perform the work, should the circumstances warrant such an assessment, in the overall interest of the Owner.
- 1.9 Each bidder shall submit only 1 (one) bid, either individually. A bidder who submits or participates in more than 1 (one) bid will be disqualified.
