

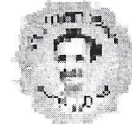

NOTICE INVITING E-TENDER

Undersigned, on behalf of CGM & HOP, AGBP, NEEPCO Ltd. Invites ON LINE Sealed bid in two bid system with 180 (one hundred eighty) days validity from experienced qualified bidders for supply of Liquid Chlorine at AGBP. NEEPCO, Bokulani, Dibrugarh.

Name of the work: Supply of Liquid Chlorine as per technical specification as follows /details as specified in the technical specification as per section - IV of bid document.

The detail bid documents shall be available at <https://etenders.gov.in>. Last date and time of submission of bid is 25.12.2019 up to 12:00 Hrs. and the same shall be opened on the same date at 15:30 Hrs.

1.0 Brief Scope of Work:

- Successful bidder shall have to supply Liquid Chlorine as per specification as stated in technical details as specified in Section IV as per applicable IS standard up to destination i.e AGBP, NEEPCO, Bokuloni, Dist: Dibrugarh Assam: 786 191. The supplier shall have to supply liquid chlorine in Chlorine Tonners each having capacity of storing 900 Kg of chlorine in batches as per dispatch clearances issued from tendering authority or his authorized representative within 45 days from the date of issuance of dispatch clearance.
- The supplier shall have to lift/collect empty chlorine tonners from site i.e AGBP NEEPCO, Bokuloni at their own cost and shall have to supply the same at the same tonners without any alteration. The supplier shall arrange/ organize transporter accordingly.
- ***At a time, 07 (seven) numbers of chlorine tonners shall be offered to the supplier for refilling i.e each batch shall contain approx. 6.3 Ton of chlorine.***
- The quoted rate shall include all the expenses i.e from lifting/collection of empty tonners from site to delivery of filled tonners up to destination (AGBP, NEEPCO) except GST which shall be paid extra as applicable.
- In case of any defect found in valves during filling at the filling station, the same shall have to be replaced and the amount incurred thereby shall be reimbursed to the supplier at actual against submission of separate invoice supported with documentary evidence.
- The supplier shall have to carry out testing of each tonner once during tenure of contractual period as per norms and shall obtain test certificate duly stamped and signed by authorized inspectorial authority. The supplier shall submit the test certificate in original to NEEPCO and the expenditure incurred toward such testing shall be reimbursed to the supplier at actual against submission of separate invoice supported with documentary evidence of actual expenditure incurred thereby.

2.0 Qualifying Requirement for Bidders:

The bidder must be a manufacture or an authorized dealer or reputed supplier having past credential of supplying similar nature of items to any Govt/PSU/or any reputed private party organization.

- a) In case of manufacturer, the bidder shall have to upload documentary evidence of the same.
- b) In case of authorized dealer, the bidder shall have to upload valid authorization certificate issued by the manufacturer.
- c) In case of supplier, the bidder shall have to upload copy of purchase order/work order issued by any Govt/PSU/reputed private sector organization of executing similar nature of single work/supply order not less than 3,00,000.00 (three lacs) during last 3 years which shall be counted from the date of floating e tender.


NOTE: without fulfilling prequalification criteria as stated above, submitted bid shall be technically rejected.

3.0 In General:

Issuance/downloading of bidding documents to any bidder shall not construe that bidder is considered as qualified.

The purchaser reserves the right to accept or reject any bid and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidders, nor does it have any obligation to inform the bidders of the ground for such action on the part of the purchaser.
