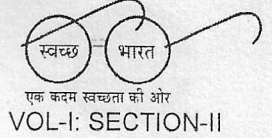

1. Qualifying Requirement:

1.1 Technical

Experience of having successfully completed similar nature of work during last 7 years should be either of the following:-

- i) One similar work viz. Construction and Painting of Steel Structures or Painting of Steel Structures, etc., costing not less than the amount equal to 80% of the estimated cost.
OR
- ii) Two similar works viz. Construction and Painting of Steel Structures or Painting of Steel Structures, etc., each costing not less than the amount equal to 50% of the estimated cost
OR
- iii) Three similar works viz. Construction and Painting of Steel Structures or Painting of Steel Structures, etc., each costing not less than the amount equal to 40% of the estimated cost.
 - a) Copies of Work order along with completion certificates in support of experiences, Income Tax PAN, EPF registration, Labour registration (Central), GST Registration of current validity are to be submitted along with the bid.
 - b) Bidders must be ready to produce the original documents if asked for failing which their bids will be summarily rejected.

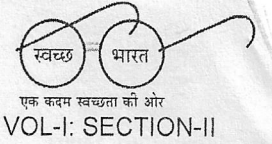

1.2 Financial

i) Minimum Average Annual Turnover:

Minimum Average Annual Turnover in the best 3 (three) financial years out of the last 5 (five) financial years, ending 31st March of the previous financial years, should not be less than Rs 90,34,400.00 only.

ii) The liquid Asset:

The bidder should have a liquid asset or/and evidence to availability of unutilized credit facilities of not less than Rs. 12, 54,800.00. The Certificate of Banker regarding the availability of unutilized credit facilities (Fund based or Non-Fund based) shall not be dated earlier than 30 (thirty) days prior to the latest date for submission of bids.

iii) Net Worth:

Net worth of the bidder as on last day of the preceding financial year, ending 31st March of the previous financial year should not be less than 50% of the paid up capital. The Net Worth shall be calculated based on Subscribed and Paid-up Capital + Free Reserves + Unallocated balance surplus amount of Profit and Loss Account less (a) Expenses not written off (b) Loss in Profit & Loss Account if not reduced from Reserves.

Complete Audited Annual Reports along with Audited Balance Sheets, Profit and Loss Account & detailed Schedule and other financial statements for the preceding 5(five) financial years, ending 31st March of the previous Financial Year, along with Letter of adequacy and commitment from their Bankers/ Financial Institutions of International repute should be furnished along with their bids for evaluating the above financial criteria. In case where the audited results of the preceding financial years are not available, certified financial statements from a practicing Chartered Accountant will be also be considered acceptable.

2. Interested bidders, who fulfill the qualifying requirements as mentioned at 1.1 and 1.2 above, may download the bid document from <https://neepco.abcpocure.com> on payment of Vendor registration fee and requisite bid fee.

3. Time of Completion:

The time for completion of the work shall be 3 (Three) months/ 90days from the date of issue of Letter of Intent/ Work Order whichever earlier.

4. Special Condition:

It should be clearly noted that all structures are already erected/placed in position, hence the quoted rate by Contractor shall account for all aspects involved in painting keeping in view the high elevation areas, available access to members etc. It is advised that the Contractor should visit the site and get himself acquainted with the nature of work completely including the extent and type of scaffoldings etc. required, before quoting his rate.

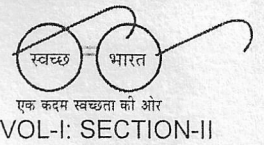

5 Relaxation of Norms for Startups and Micro & Small Enterprises (MSEs) on Prior Experience and Prior Turnover criteria:

In line with the Policy Circular No. 1(2)(1)/2016-MA dated March, 2016 of the Ministry of Micro, Small & Medium Enterprises on "relaxation of norms for Startups and Micro & Small Enterprises in Public Procurement on Prior Experience and Prior Turnover criteria" and as per Section 2.1(5) of Action Plan for "Startup India" announced by the Government of India in Jan 2016, the Criteria of Prior Turnover and Prior Experience are exempted for the Startups and Micro & Small Enterprises for this tender, subject to meeting of quality and technical specifications.

The Startup Enterprises shall submit startup India recognition certificate issued by the Department of Industrial Policy and Promotion (DIPP) of Ministry of Commerce & Industry in order to be considered for relaxation in prior experience and prior turnover.

6. Conditions for Micro & Small Enterprises (MSEs):

6.1 The bidders participating as Micro/Small Enterprises (MSE) shall submit an Undertaking in the prescribed format (Form D, Section-V) declaring the status of their firm under the provisions of Micro and Small Enterprises along with a copy of the relevant document/certificate issued by any of the Authority mentioned below:

- o District Industries Centers
- o Khadi and Village Industries Commission
- o Khadi and Village Industries Board
- o National Small Industries Corporation (NSIC)
- o Directorate of Handicrafts and Handloom
- o MSEs having Udyog Aadhar memorandum
- o Any other Body specified by Ministry of Micro, Small and Medium Enterprises.

The MSEs owned by Scheduled Caste (SC) & Scheduled Tribe (ST) entrepreneurs; the SC/ST certificate issued by District Authority must be submitted in addition to certificate of registration with any one of the agencies mentioned above. The bidder shall be responsible to furnish necessary documentary evidence to ascertain that the MSE is owned by SC/ST. MSE owned by SC/ST is defined as:

- a) In case of proprietary MSE, proprietor(s) shall be SC /ST
- b) In case of partnership MSE, the SC/ST partners shall be holding at least 51% shares in the enterprise.
- c) In case of Private Limited Companies, at least 51% share shall be held by SC/ST promoters.

6.2 The registration certificate issued from any one of the above agencies must be valid as on close date of the tender. The successful bidder should ensure that the same is valid till the end of the contract period.

6.3 The MSEs who have applied for registration or renewal of registration with any of the above agencies/bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/preference.

6.4 The MSEs registered with above mentioned agencies/bodies are exempted from payment of Bid Fees and Earnest Money Deposit (EMD).

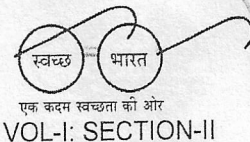

7 Participation in Bids:

7.1 Portal Registration for e-tendering:

The bidders intending to participate in the e-tendering and to download the detailed bid document have to register themselves in the NEEPCO's e-tendering portal <https://neepco.abcprocure.com>. The registration of bidder once registered shall be valid for one year from the date of activation of bidder profile.

The Bidders who have already registered in NEEPCO's e-tendering portal having valid registration need not to register again. However, such bidders are to ensure that their registration in the e-tendering system is valid till the completion of the entire bidding process of the relevant NIB.

7.2 Portal registration fee:

The fees for Bidder Registration in the portal is Rs. 3000.00 (Rupees three thousand) only per year (Nonrefundable).

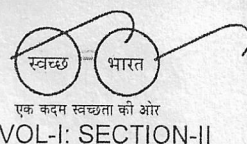

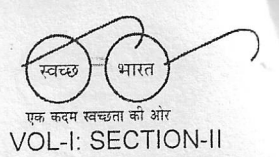
